

## COMPARISON OF 13-INCH-CLASS 2-in-1 LAPTOPS

We compared the Dell™ XPS™ 13 2-in-1 to others in its class from vendors including Acer®, ASUS®, Fujitsu®, HP, Lenovo®, Microsoft®, Samsung®, Toshiba®, and VAIO®. Figure 1 compares the systems using publicly available data at each vendor's respective website. We gathered this data at the links provided on 04/19/2017 (click on model names to follow them) and report only what each vendor disclosed on their sites.

According to vendor-provided data, the new Dell XPS 13 2-in-1 is the smallest 13-inch 2-in-1 laptop.
