

## COMPARISON OF 13-INCH-CLASS 2-IN-1 LAPTOPS

We compared the Dell™ XPS™ 13 2-in-1 to others in its class from vendors including Acer®, ASUS®, Fujitsu®, HP, Lenovo®, Microsoft®, and Samsung®. Each system we compared has a 13.3-inch screen size unless otherwise noted. Figure 1 compares the systems using publicly available data. Click a system's name to visit its page on the vendor's website. We gathered this data at the links provided on 08/20/2018 and report only what each vendor disclosed on their site.

According to vendor-provided data, the Dell XPS 13 2-in-1 is the smallest 13-inch 2-in-1 laptop.
