

COMPARISON OF 15-INCH-CLASS 2-IN-1 LAPTOPS

We compared the Dell™ XPS™ 15 2-in-1 to others in its class from vendors including Acer®, ASUS®, HP, Lenovo®, Microsoft®, and Samsung®. Each system has a 15.6-inch screen unless otherwise noted.
